

CARES Act Grant (HEERF II)- Moler Hollywood Beauty Academy

Higher Education Emergency Relief Fund Reporting  
Emergency Financial Aid Grants to Students (as of 12/31/2021)

- On 7/14/2021 Moler Hollywood Beauty Academy signed and submitted the student's portion application for the CARES Act Grant. (HEERF II)
- Moler Hollywood Beauty Academy has received \$59,064.00 from the Department of Education in Emergency Financial Aid Grants for students. (HEERF II)
- As of 12/31/2021, Moler Hollywood Beauty Academy has distributed \$37,594.44 in Emergency Financial Aid Grants (HEERF II) to the students.
- As of 12/31/2021, there was a total of 58 students enrolled and eligible at Moler Hollywood Beauty Academy to participate in the Federal student financial aid programs under Section 484 of the Higher Education Act of 1965, as amended, and thus are eligible to receive Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES Act.
- As of 12/31/2021, there has been a total of 58 students who have received an Emergency Financial Aid Grant under Section 18004(a)(1) of the CARES Act.
- Eligible students were made aware in a student meeting regarding the available funding provided by the Department of Education through the CARES Act.
- The method used by Moler Hollywood Beauty Academy to determine which students would receive Emergency Financial Aid Grants.
  - In accordance with guidance published by the U.S. Department of Education, student grants will be distributed only to students who are Title IV eligible. An eligible enrolled student includes any student who has not been withdrawn, to include students progressing via temporary distance education. Students who are on an approved Leave of Absence due to issues related to COVID19 that began on or after January 1, 2021, are considered actively enrolled and are eligible to receive their share(s) of the Grant Fund. The currently attending student roster will be determined by taking a census of the student body as of January 1, 2021. Any student withdrawn from the Institute prior to January 1, 2021, is not an eligible student and will not receive a grant award under this plan. Students who have filed a Free Application for Federal Student Aid (FAFSA) and for which the Institute has a current Institutional Student Information Record (ISIR) demonstrating Title IV eligibility will be considered Title IV eligible for purposes of the grants to be disbursed under this plan. Students enrolled as of January 1, 2021, who did not previously file a FAFSA but are U.S. citizens, or eligible non-citizens, may certify to the Institute that they are eligible to participate in the Title IV Federal Student Aid programs and therefore eligible to receive an emergency financial aid grant.
  - Students must be 18 years or over, or if younger, currently receiving Title IV assistance.
  - Must have a graduation date on or after January 1, 2021.
  - The school will distribute the funds in one disbursement and will divide the funds available equally among the students who meet the above criteria.
